I/We, the undersigned, being the owner(s) of one or more lots of the Eastridge Addition to the Town of Jackson, Teton County, Wyoming, DO HEREBY AMEND said DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR EASTRIDGE ADDITION TO THE TOWN OF JACKSON, dated August 29, 1991 and recorded August 29, 1991 in Book 241 of Photo at pages 372 to 402 in the records of the Clerk of Teton County as follows:

Section 8.18. (b) is amended to read:

- (b) Dogs and other domestic animals shall be controlled and restrained at all times. Pet waste shall not be allowed to remain on streets, Common Areas or properties not owned by the pet owner. Pets shall not be allowed to run at large on any portion of any Lot except within an enclosed improvement area;
