I/We, the undersigned, being the owner(s) of one or more lots of the Eastridge Addition to the Town of Jackson, Teton County, Wyoming, **DO HEREBY AMEND** said DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR EASTRIDGE ADDITION TO THE TOWN OF JACKSON, dated August 29, 1991 and recorded August 29, 1991 in Book 241 of Photo pages 372 to 402 in the records of the Clerk of Teton County as follows:

Section 7.4 (c) is amended to read:

Driveways. Except for Lot #1, all lots shall have building access on Henley Road or Henley Court. Lot #1 shall have one access from either Henley Court or Hansen Avenue. The individual Lot Owner shall provide a hard surface driveway, of preferable a "chip / seal" material, unless otherwise approved by the Site Committee. The minimum width of each driveway shall be ten (10) feet and the maximum width shall be twenty-four (24) feet.

IN WITNESS WHEREOF, the undersigned lot owner(s) have hereunto set our hands to be effective upon receipt of the approval of the required Seventy percent (70%) of all Lot Owners.
