

**AMENDMENT TO DECLARATION OF
PROTECTIVE COVENANTS
LAKE CREEK ACRES SUBDIVISION**

This amendment of the Declaration of Protective Covenants, Lake Creek Acres Subdivision, recorded in the Office of the County Clerk of Teton County, Wyoming, on April 1, 1977 in Book 56 of Photo, Pages 272-277, is made by the undersigned owners of lots in said subdivision in accordance with Article 14 of the Declaration, effective July 1, 1982.

Article 11 is hereby amended to read as follows:

11. DIVISION OF LOTS. Lot 1 may be divided once, with each lot resulting from such division comprising an area of not less than three (3) acres. Lots 2 through 9, inclusive, shall not be divided in any manner.
