Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14 of Valley View Subdivision are hereby exempted from the restrictions contained in the covenants to in order to permit the use of said lots for commercial purposes, including buildings and improvements, signage, and lot subdivision, to the full extent permitted by Teton County zoning and building regulations.
